

Terms and Conditions for Shell x Pokémon 2024 Promotion

1. These terms and conditions shall apply to the Shell x Pokémon Promotion 2024 (“**Promotion**”) organised by Shell Singapore (Pte) Ltd (“**Shell**”).
2. Participation in this Promotion constitutes acceptance of these terms and conditions of Promotion.
3. “**Promotion Period**” is from 26 August 2024 to 30 November 2024 (both dates inclusive), within which the Promotion will run subject to the terms and conditions herein.

Eligibility Criteria for Promotion

4. This Promotion is available to customers:
 - a) who makes a qualifying purchase at any Shell station and is also a valid Shell GO+ member; referred to as the “**Eligible Customers**”.

Promotion

5. Qualifying Purchase at Shell stations:

During the Promotion Period, Eligible Customers make a qualifying purchase of minimum S\$70 gross spend at Shell stations **EXCLUDING** tobacco and in-store service items and must be a valid Shell GO+ member (the “**Qualifying Purchase**”).
