

Terms and Conditions for Shell Fuels for Deal\$ (FFD) Promotion 2021

1. These terms & conditions shall apply to this FFD promotion (“Promotion”) organized by Shell Eastern Petroleum (Pte) Limited (“Shell”).
2. By taking part in this Promotion, you agree to be bound by these Promotion Terms and Conditions and the decision of Shell in relation to and in connection with the Promotion.
3. “Promotion Period” is from 1 June 2021, 0700h, to 30 June 2021, 2359h , or if the FFD Product (defined below) is out of stock, whichever earlier.
4. “FFD product” refers to Shell Shampoo Starter kit – which consists of a Shell Premium Car Shampoo and a pack of Shell Microfibre Cloth
5. “Special promotion price” is the price of FFD product offered to Participants (as defined below).
6. Shell reserves the right to change the Promotion Period in its sole and absolute discretion.

Eligibility and Promotion

7. During the Promotion Period, customers who meet the following eligibility criteria (“Participants”):
 - a. For drivers: a gross spend of at least Sixty Singapore Dollars (S\$60) (before GST / taxes / discount) on Shell fuels; namely: Shell V-Power, Shell Fuelsave 98, Shell Fuelsave 95 and/or Shell Fuelsave Diesel (collectively the “Shell Fuels”) or
 - b. For riders: a gross spend of Ten Singapore Dollars (S\$10) (before GST / taxes / discount) on Shell Fuels, are eligible to purchase the FFD product at Special Promotion price at any Shell stations, subject to the terms and conditions herein.
8. Redemption and FFD Product is available only while stocks last and only with original Shell Fuels purchase receipts.
9. All FFD Product are non-transferable, non-refundable and not exchangeable for cash, credits, or for other goods and services, or otherwise, either partially or wholly.
10. The FFD Product shown on any advertising materials are for illustration purposes only. The design and colour of the FFD Product may differ from the pictures shown.
11. Shell reserves the right to, at any time and in its sole and absolute discretion, replace and/or substitute the FFD Product with an alternative item of any value.
12. Shell makes no warranty or representation (whether express or implied) on the quality, merchantability or suitability for use of the FFD Product. Shell shall not be liable to the fullest extent permitted by law for any loss, injury or damage that may be suffered or incurred by any person in connection with the Promotion, the FFD Product or its use. A customer or person registering or taking part in the Promotion undertakes not to make or bring any claim against Shell in connection with the foregoing, to the fullest extent permitted by law.

General

13. The decisions of Shell on all matters relating to or in connection with the Promotion are final, conclusive and binding. Shell shall not be obliged to give any reason or enter any correspondence with any person on any matter concerning the Promotion.

Shell reserves the right at any time in its sole and absolute discretion to determine and/or amend or vary these terms and conditions without prior notice, including but not limited to cancelling, terminating or suspending this Promotion, the eligibility terms and criteria, the redemption of the FFD Product and/or its substitution, and the timing of any act to be done, and all Participants shall be bound by these amendments.

Shell shall not be liable or responsible to the fullest extent permitted by law for any injury, loss or damage suffered as a result of, or in connection with the Promotion howsoever arising, including but not limited to, the redemption and use of the FFD Product, any breakdown or malfunction in any computer system or equipment, any notice which is misdirected and/or lost in the post, loss of income, profits or goodwill, as well as any other direct or indirect, incidental, consequential, exemplary, punitive or special damages of any party including third parties howsoever arising whether in contract, tort, negligence or otherwise. For the avoidance of doubt, cancellation, termination or suspension by Shell of this Promotion shall not entitle any party to any claim or compensation against Shell for any and all losses or damage suffered or incurred as a direct or indirect result of the act of cancellation, termination or suspension.

16. In the event of any inconsistency between these terms and conditions and any advertising, promotional, publicity and other materials relating to or in connection with the Promotion, these terms and conditions shall prevail.

17. By participating in this Promotion, all Participants agree to be bound by these terms and conditions. The Promotion and these terms and conditions shall be governed by the laws of the Republic of Singapore and all Participants are deemed to have agreed to submit to the exclusive jurisdiction of the Singapore Courts.

18. A person who is not a party to any agreement governed by these terms and conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any terms of such agreement
