Terms and Conditions for "What's The Hack?" New Shell Fuels Launch Social Contest Post (2019)

- 1. These terms and conditions shall apply to the <u>"What's The Hack?" New Shell Fuels Launch Social</u> <u>Contest Post (2019)</u> ("Contest") and is organised by Shell Eastern Petroleum (Pte) Ltd ("Shell").
